### 4 First aid measures

- **General information** Instantly remove any clothing soiled by the product.

- **After inhalation**

Supply fresh air. If required, provide artificial respiration. Keep patient warm. Consult doctor if symptoms persist.

- **After skin contact**

Instantly wash with water and soap and rinse thoroughly.

### 6 Accidental release measures

- **Person-related safety precautions:**
  - Wear protective equipment. Keep unprotected persons away.
